

Regional CEDS Five Year Plan

As an Economic Development Administration (EDA) designated Economic Development District (EDD), Blackhawk Hills Regional Council is required to write and maintain the Comprehensive Economic Development Strategy (CEDS) for the six-county region of Carroll, Jo Daviess, Lee, Ogle, Stephenson, and Whiteside. The CEDS should represent all of the counties and the entities within.

CEDS is a plan that emerges from a broad-based continuous planning process addressing the economic opportunities and constraints of a region. A CEDS should promote economic development and opportunity, foster effective transportation access, plan for regional disaster resiliency, enhance and protect the environment, and balance resources through sound management development practices.

An acceptable CEDS is typically a prerequisite to be eligible to receive funds under most EDA programs. A CEDS is required to qualify for assistance under its public works, economic adjustment, and most planning programs. EDA uses this document as a means to identify potential projects in our region, so it is in the best interest of those located within the six-counties to highlight your needs so they can be included.

The CEDS Plan is completely reconstructed every five years and updated annually. Blackhawk Hills Regional Council's Five Year CEDS Plan is due by May of 2014. As this process moves forward, staff will be actively seeking input from the leaders in the region to reassess the needs and constraints that impact our economic and community development. There will be a number of in-put sessions and roundtable meetings scheduled throughout the region to help gather the vital information for our state and federal funding agencies. You may be called upon to participate in some of the information gathering activities and it is our hope that you will contribute to the discussions.

Bikes Belong Coalition - Community Partnership Grants

The Bikes Belong Coalition is dedicated to encouraging bicycle usage and expanding bicycling opportunities. The Coalition is currently accepting applications for community partnership grants. A partnership consists of at least one local government, a non-profit organization with a mission to support bicycling recreation, and a local business. The goal of the program is to foster partnerships between these entities to improve a community's bicycling environment. Grants may be used for the development or expansion of bicycling facilities including paths, trails, and bike lanes. Grants may also be used for advocacy projects that promote bicycling. Applicants may apply for up to \$10,000, but proposals that request funding for 50% or more of the project will not be considered. The program awards \$180,000 yearly and funds approximately 15-20% of the proposals it receives. Application deadline is May 24, 2013.

Illinois Open Space Lands Acquisition and Development Program

The Illinois Open Space Lands Acquisition and Development Program (OSLAD) is a state-financed grant program that provides reimbursement of up to 50% to local governments for the acquisition and/or development of land for public parks and open space. Communities that apply and are approved for a project must be able to finance the entire cost of the project and provide receipts prior to grant reimbursement. The OSLAD Program is financed by a percentage of the state's Real Estate Transfer Tax. Grant awards of up to \$750,000 are available for acquisition projects, while development/renovation projects are limited to a \$400,000 grant maximum. Examples of projects available by visiting the Illinois Department of Natural Resources website. Application deadline is July 1, 2013.

Investing in Manufacturing Communities Partnership

The Investing in Manufacturing Communities Partnership (IMCP) is a new Administration-wide initiative that will accelerate the resurgence of manufacturing and help cultivate an environment for businesses to create well-paying manufacturing jobs in regions across the country. The IMCP is designed to reward communities that demonstrate best practices in attracting and expanding manufacturing by using long-term planning that integrates targeted investments in workforce training, infrastructure, research, and other key assets. Application deadline is June 13, 2013.

Theresa Wittenauer Appointed to QCREDA by Governor Pat Quinn



Theresa Wittenauer, Economic Development Coordinator for Blackhawk Hills Regional Council, has been appointed to the Board of Directors of the Quad Cities Regional Economic Development Authority (QCREDA). QCREDA was created by action of the Illinois General Assembly in 1987 and serves Henry, Knox, Mercer, and Rock Island Counties. QCREDA also serves Carroll, Jo Daviess, Lee, Stephenson, and Whiteside Counties within the Blackhawk Hills region. Six positions of the eleven member board are appointed directly by the Governor of Illinois with the consent of the Illinois Senate.

QCREDA is a general development agency whose financial and supportive powers enable it, with written approval of the Governor of Illinois, to issue taxable bonds, tax-exempt bonds, issue moral obligation bonds, and/or issue notes or other evidences of indebtedness for the purpose of developing, constructing, acquiring, or improving properties or facilities for business entities locating in or expanding within QCREDA'S territory.
